on New Launches, Sharing of EOL Stocks of Members etc. have been included. Some of these sections are under construction and will be activated soon.











COMPASS ANKUR & CSR ACTIVITIES





Our emphasis this year is to improve the student strength at COMPASS Ankur Computer Training Center and incorporate systems in our training to help in quality and employbility of the students.

ACTIVITIES @ GST - AT A GLANCE

COMPASS has always tried to help members updating their knowledge for any new statuary compliance levied by the Government. In relation to GST your association has played a pivotal role and would like to share with you the following activities which we have done.

- 1. Our members have participated in 12 seminars organized by different parent associations on GST.
- 2. We were in continuous touch with the State Government Officials for getting regular updates.
- 3. We have send advisory mail to all COMPASS members.
- 4. We have send advisory to all OEM's for protecting IT Channel Interest.
- CWBTA had organized an informal meeting with the Members of GST council, President & Secretary of various associations and we had raised our concern related to IT industry.
- 6. We have done GST Seminar on 5th June 2017 at The Park hotel, just after the very important meeting on 4th June by GST Council. This was attended by 300+ members with their Sr. Accountant, wherein keynote speaker was Mr.T.B. Chatterjee and Chief Guest was Mr. Khalid Aizaz Anwar Sr. Jt. Commissioner and member of GST Council. This meet was very fruitful and effective and was appreciated by the attendees.
- 7. In the first 2 weeks of June 2017 we were fully focused on giving letters, mails and representation to Government for making GSTTax rate uniform for all IT products @ 18%.
 - a. We have sent letters to the Hon. Finance Minister, GST Council (10 letters) for making the rate uniform.
 - b. We have mailed to the Finance Ministry, GST Council and others for making the rate uniform.
 - c. Through CWBTA we have given representation in Nabanna and have given memorandum from COMPASS side.
 - d. We have represented with FAIITA in giving Memorandum to IT Minister Shri Ravi Shankar Prasad in Delhi.
 - e. Our parent association FAIITA has represented and given Memorandum to Mr. Vinod Kumar (Co-Convener GST Council) in Bangalore.

- 8. We have deputed our EC member Mr. Shiv Mohta for getting trained in Capacity Building Program of Commercial Tax Dept., so that our members can contact him for any help.
- P. We have sent advisory to members which we had received from CIITA and the same has been send to all OEM's in June 2017 for protection of Channel Interest especially related to existing stock and MRP issue.
- 10. Our parent association FAIITA had sent an advisory related to all the OEM's for protection of IT Channel interest especially loss on existing stock.
- 11. Our delegation along with CWBTA had met Finance Minister Shri Amit Mitra requesting him for making uniform rate for all IT Products.
- 12. Several emails were sent to members updating about new informative inputs on GST i.e. MRP rules, process for filling up of forms etc regularly.
- 13. We have appointed a GST consultant and have started weekly GST Helpdesk, wherein day to day queries of the members can be resolved. We have circulated at Helpdesk a list of tentative HSN codes of IT Products. We have also conducted training on Filling of GSTR-3B / GSTR-1 / TRAN-1 Return Forms. COMPASS acknowledges and thank CA Shweta Bagaria Sarawgee of M/s. Bharat D Sarawgee & Co., Chartered Accountants for conducting the GST helpdesk. We also thank Mr. K. L. Lalani for providing us Lalani Infotech Conference room for GST Helpdesk.
- 14. We were one of the sponsors of "GST- Road Ahead" held in Kalamandir on 31st August 2017 wherein Chief Commissioner and many Senior Government Officials of Commercial Tax Department were speakers and the Seminar was presided over by Chief Guest Hon'ble Finance Minister Dr. Amit Mitra and the icing on the cake was our Hon'ble Chief Minister Ms. Mamta Banerjee who gave keynote speech through Mobile and addressed the gathering and assured full support to the Trading Community as a whole.
- 15. GST Master Classes CD conducted by Dr. Hasmukh Adhia was given on request to members and the same has been uploaded in our website.


