- 1. Candidate should not have any sort of dues to COMPASS as on **31<sup>th</sup> day of August**, **2021**.
- The Proposer and Seconder should be a member of COMPASS and should not have any sort of dues to COMPASS as on 31<sup>th</sup> day of August, 2021.
- 3. The form must be duly signed (with Rubber Stamp) by the Proposer, Seconder and the candidate as per the prescribed form and must be submitted to the Compass Office on or before 16th September, Thursday, 2021 by 6.00 PM.
- 4. Life Members and Annual Members who have no dues as on 31<sup>th</sup> day of August, 2021. and who are enrolled as members on or before 31<sup>th</sup> day of August, 2021. are only eligible to cast their votes in this year 2021 2022.
- 5. Members who will not be present at the Election venue will not be entitled to cast their vote by proxy. They may however contact the Election Officer for casting their vote by **postal ballot**, latest by **20th September**, **2021.** by mail.
- 6. Eligibility criteria for the post of President, Member must have experience of minimum 2 years as Office Bearer of COMPASS.
- 7. Eligibility criteria for the post of Executive Committee Member, Member must be more than 2 yearold member of COMPASS.
- Elections, if necessary, shall be held by secret ballot / Electronics voting between 8.00 PM and 8.30PM at at The Spring Club. 5 JBS Halden Avenue (EM Bypass) Kolkata - 700 105, on Saturday, 25<sup>th</sup> day of September 2021.
- 9. The Election Officer may decide to extend / alter the deadlines specified above if required, within the framework of the Memorandum & Articles.
- 10. All Rules and Regulation are applicable as per the Memorandum and Articles of Association.
- 11. As per Memorandum and Articles of COMPASS, any existing Committee Member, should have attended at least 50% of the Committee Meetings in 2020 2021, to be eligible to seek reelection.
