# TERMS & CONDITIONS FOR BOOKING IN COMPASS Tech Fair 2022

## **FACILITIES:**

EACH STALL of 6 OR 4 Sqr. Mtr. WILL HAVE THREE SIDE OCTONORM HELD BY PRE-FABRICATED ALUMINIUM SYSTEM WITH FASCIA (NAME IN ENGLISH Max. 25 LETTERS). IN CASE OF CORNER BOOTHS IT WILL BE TWO SIDEWALLS AND TWO FASCIA BOARDS. PROVIDED WITH 2 TABLES, 2 CHAIRS, 3 OR 2 SPOTLIGHTS & ONE 5 AMP. POWER SOCKET.

- Extra Tables, Chairs, Racks, Spotlights & Power Sockets Shall be Provided by Contractor on Request Against Payment.
- The Organisers shall provide adequate Security; however the sole responsibility lies with the Exhibitor against any damage or loss of their exhibits.
- Persons participating in the exhibition are expected to behave in a manner that does not cause injury or damage or harm to any other person, exhibits, or to the property of the Contractors and exhibition hall.
- The Organisers reserves the right to remove any product, services or signage of any kind which they may find to be not related with the theme of the exhibition.
- Products causing loud noise, giving objectionable odour or inflammables in nature are not allowed. Food and drinks are strictly not allowed inside the exhibition hall.
